Northbound: Proceed northeast from the intersection of Post Rd. and Elmwood Ave. (US-1). Continue to the intersection of Warwick Ave. (RI-117). Take a left. Continue to the intersection of Broad St. Take a *slight* right turn on to Norwood Ave. Continue to the intersection of Narragansett Blvd. Take a left. Continue to the intersection of Eddy St. (Note: Narragansett Blvd. becomes Allens Ave.). Bear right. Continue to the intersection of Point St. Take a right. Continue to bridge. On the other side of the bridge, take a right at the first light. Continue to end. Take a left onto I-195. Proceed on I-195 to Exit 8. Take a right at the end of the ramp. Go to the first traffic light. Take a right. Continue to the fork with Newport Ave. Bear right on to Newport Ave. Continue to the Massachusetts state line.

Southbound: Proceed southbound from the Massachusetts state line to the intersection of Pawtucket Ave. Bear left. Continue to the fork with Route 114A. Bear right. Continue to the I-195 interchange. Take I-195 westbound. Take Exit 2. Take a left at the first traffic light ontoWickenden St. Go over the Point St. Bridge where road name changes to Point St. Proceed on Point St. westbound to the intersection of Eddy St. Take a left. Go to the intersection of Allens Ave. (just before the I-95 overpass. Bear left. Proceed to the intersection of Norwood Ave. Take a right. Proceed to the intersection of Broad St. Bear to the left on to Warwick Ave. (RI-117). Continue to the intersection of Post Rd. Take a right. Continue to the intersection of Elmwood Ave.

Northbound:

<u>HIIS 086000</u>: Proceed southbound on Main St. from the intersection of Main St. and Broad St. in Westerly. At the fork between Margin St. and Beach St., bear left. Continue to the intersection of Elm St. Curve to the right. Continue to the intersection of Shore Rd. Take a left. Continue to the intersection of US-1.

Proceed on US-1 northbound to the exit at the Charlestown Visitors' Center.

<u>HIIS 090600</u>: Proceed northeast from the exit off US-1 northbound at the Charlestown Visitors' Center. Continue until the road re-enters US-1.

Take the next exit on US-1.

<u>HIIS 136300</u>: Continue until the road re-enters US-1. Take the U-turn signed "Post Rd. - Perryville" on US-1. and take that exit off US-1 southbound. Continue until the road re-enters US-1.

Go back on to US-1 northbound. Take Wakefield turnoff to re-enter US-1 southbound. Take Wakefield exit off US-1 southbound.

HIIS 208900: Proceed to the intersection of RI-108.

Take a right. Proceed to rotary. Take second road off rotary.

<u>HIIS 086200:</u> Continue to the intersection of Caswell St. (the end of the road). Take a left. Road curves sharply to the right and ends at a traffic light by the waterfront. Take a left here. Continue for many miles to the intersection of Brown St. and Phillips St. Take a right. And continue to the intersection of West Main St. Take a left. Continue to the intersection of US-1.

Southbound:

HIIS 086200: Proceed eastbound on West Main St. from the intersection of US-1. Proceed to the intersection of Brown St. Take a right. Continue to the intersection of Boston Neck Rd. and Phillips St. Take a left. Proceed for several miles to the intersection of Narragansett Ave. (just beyond Narragansett Town Beach). Take a right. Road curves sharply to the left. Go to the first traffic light. Take a right. Continue to the rotary.

Take first road off rotary. Continue to the intersection of Main St. Take a left.

HIIS 208900: Continue until the road enters US-1.

Take exit near Matunuck Beach Rd. turnoff (take exit, *not* turnoff).

<u>HIIS 136300</u>: Continue until road re-enters US-1. Take Green Hill Beach Rd. turnoff to get back on to US-1 northbound. Take Green Hill Beach Rd. exit off US-1 northbound. Continue until road re-enters US-1.

Take turnoff to re-enter US-1 southbound, then take first turnoff to re-enter US-1 northbound. Take first exit off US-1 northbound.

<u>HIIS 090600</u>: Continue until road re-enters US-1 (Charlestown Visitors' Center is on left).

Take turnoff to re-enter US-1 southbound. Continue to the fork between US-1 and Route 1A. Bear left.

<u>HIIS 086000</u>: Continue to the intersection of Watch Hill Rd. (the end). Take a right. The road later becomes Beach St. Continue to the intersection of Beach St. and Elm St. Curve to the left. Proceed to the intersection of Main St. and Margin St. Bear right. Continue to the intersection of US-1 (Union St.).

Take a left. Continue to fork between Broadway and Westminster Street. Bear right at this fork to go onto Westminster Street. Follow to traffic light at the intersection of Cranston Street and Fricker Street (Citizens Bank is on left hand side of this intersection). Bear left to stay on Westminster Street. Continue to the intersection of US-1N (at Bishop McVinney Auditorium just beyond the I-95 overpass).

Westbound: Proceed westbound from US-1N at Bishop McVinney Auditorium. Continue to the fork between Westminster Street and Cranston Street. Bear right at this fork to stay on Westminster Street.
